

RESOLUTION TRANSFERRING FUNDS FROM THE ASHTABULA COUNTY DEPARTMENT OF JOB & FAMILY SERVICES TO THE ASHTABULA COUNTY CHILDREN SERVICES BOARD

WHEREAS, the Ashtabula County Department of Job and Family Services (“ACDJFS”) is the recipient of certain TANF PRC Funds, which it receives as part of its annual allocation; and

WHEREAS, on June 15, 2022, ACDJFS received an allocation notice from the State of Ohio setting forth the SFY 2023 TANF Block Grant- Kinship Caregiver Program Allocation for ACDJFS for the period of 7/01/2022 through 6/30/2023 with an award amount of \$100,370.00; and

WHEREAS, Ashtabula County Children Services Board (“ACCSB”) provides protective services for children who may be placed with relatives who are eligible for financial assistance, which are available through SFY 23 TANF PRC Kinship Caregiver Funds; and

WHEREAS, in exchange for providing such services, the Executive Director of the ACDJFS finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Ashtabula to authorize the transfer of \$100,370.00 of SFY 23 TANF PRC Funds to ACCSB to be used for the Kinship Caregiver Program costs; and

WHEREAS, the Executive Director of the ACDJFS is hereby authorized to execute any documents necessary to effectuate said transfer; and

WHEREAS, this Board of Commissioners would agree with the recommendation of ACDJFS to transfer said funds; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the Ashtabula County Department of Job and Family Services (“ACDJFS”), is hereby authorized to transfer an amount of \$100,370.00 and to execute any documents necessary to effectuate said transfer.
