

**RESOLUTION FIXING FEES FOR THE NEW LONDON ROAD WATERLINE PROJECT AND SETTING PUBLIC HEARING ON THE MATTER, ASHTABULA COUNTY WATER SYSTEM**

WHEREAS, Ashtabula County will own and operate a water line located in the unincorporated areas of the County and connected to the Ashtabula County Water System, known as the New London Road Waterline in Geneva Township; and

WHEREAS, The project is further described below:

The project is located in Geneva Township. It involves the installation of 2,903 feet of 8" waterline along a section of New London Road. The starting point for this project is in parcel number 17-019-00-013-00 and marked as Station 60+00.2 on the drawings. The end point is in parcel number 17-019-00-019-00 and marked as Station 89+02.6 on the drawings.

Eight (8) New London Road parcel owners approached the Ashtabula County Department of Environmental Services in order to obtain county water. To accomplish this they have contracted with an independent contractor for the installation. Geneva Township and Ashtabula County Department of Environmental Services (ACDES) are also contributing towards the watermain cost. The eight (8) parcel owners will be paying a total of \$6,187.50 which includes the cost to an independent contractor and tap in fees. Future costs for the remaining eight (8) parcels in the identified area will be the current tap in fee of \$2,500 (subject to change), \$1,250.00 for their share of the county investment and \$2,437.50 for the equal share of the independent contractors cost for a total of \$6,187.50. This is equal to the initial eight (8) parcel owners' cost portion. The fees above, which may increase by tap-in fee only, will remain in effect until December 31, 2027. At that time the current tap-in fee costs would be required.

WHEREAS, There will be a public hearing held on August 23, 2022 at 10:30 a.m. for interested parties to attend and be heard; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the above tap-in fee and associated costs outlined above are hereby adopted for residential users of the New London Road Waterline project area. Said fees are effective immediately upon passage of this resolution.

BE IT FURTHER RESOLVED, that Ashtabula County will assume ownership of the watermain when installation is complete and the area incorporated into the Ashtabula County Water System.

BE IT FURTHER RESOLVED, that the clerk is directed to send certified mail notice of the hearing to the affected property owners.
