

RESOLUTION DECLARING PERSONAL PROPERTY OBSOLETE AND AUTHORIZING A PRIVATE SALE

WHEREAS, Pursuant to Ohio Revised Code 307.12(b) when the Board of Commissioner finds that the county has personal property, including motor vehicles acquired for the use of county officers and departments, road machinery, equipment, tools, or supplies, which are not needed for public use or are obsolete or unfit for the purpose for which it was acquired, and when the fair market value of the property to be sold under this division is, in the opinion of the Board, two thousand five hundred dollars or less, the Board may sell such property by private sale, without advertisement or public notification; and

WHEREAS, The Ashtabula County Sheriff has requested permission to sell one (1) police vehicle to the Ashtabula City Municipal Court, Probation Department, as follows:

WHEREAS, this vehicle is no longer needed for the performance of the duties of the department and is hereby authorized to be sold for \$3,000.00 to the Ashtabula City Municipal Court, Probation Department; and

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the County Sheriff be allowed to sell the obsolete vehicle at private sale in accordance with Ohio Revised Code Section 307.12(b)


