

RESOLUTION HOLDING PUBLIC MEETING REGARDING THE RETIREMENT AND RE-EMPLOYMENT OF TRACI HODGES, SOCIAL SERVICES ASSOCIATE AT THE ASHTABULA COUNTY NURSING AND REHABILITATION CENTER

WHEREAS, The Ashtabula County Board of Commissioners is the appointing authority for the Accounts Payable position at the Ashtabula County Nursing Rehabilitation Center; and

WHEREAS, Traci Hodges has notified the Board of Commissioners that she will retire on the effective date of August 27, 2022 and has asked to re-employed on September 1, 2022; and

WHEREAS, Ohio Revised Code Section 145.381 outlines the procedure for retirement and re-employment of the allowance of a person who is or most recently has been employed by a public employee in a position that is customarily filled by a vote of members of a board or commission; and

WHEREAS, a public notice regarding this public meeting was posted on the Ashtabula County Website under Public Notices in accordance with Ohio Revised Code 145.381; and

WHEREAS, this being the date and time of the public meeting regarding the retirement and re-employment of Traci Hodges, Social Services Associate at the Ashtabula County Nursing & Rehabilitation Center, public comments were heard, as follows:

WHEREAS, there were no members of the public in attendance, with no public comments being heard.

The Board of Commissioners feel that this rate of pay is fair in the current environment and Ms. Hodges has been a long-standing employee.
