

**RESOLUTION HOLDING SECOND HEARING ON THE PROPOSED REVISIONS TO THE ASHTABULA COUNTY BUILDING CODE TO PROVIDE FOR THE DEPARTMENT OF BUILDING REGULATIONS**

WHEREAS, this being the date set for the second public hearing on the proposed revisions to the Ashtabula County Building Code for the Department of Building Regulations; and

WHEREAS, David Strichko, Building Official, explained the proposed revisions and the following public comments were offered:

At the last hearing there was some clarification as to residential and commercial and how to register, as follows:

Added "acting as a General Contractor" to the Commercial General Contractor and Residential General Contractor first paragraphs and added the Note: "the owner of a one, two or three family dwelling may act as their own General Contractor and will be exempt from registering a General Contractor. The homeowner must sign a waiver accepting responsibility for the construction on a form provided by the Ashtabula County Building Department."

WHEREAS, There was one member of the public present at this hearing  
Jim Carlson, 7214 Depot Rd. spoke and thanked them for listening and making the changes, we are the only county who did not have something like this and he is for it now. He appreciates doing this and thinks it will help. Our building Department is run very well, organized and professional. He is not hearing any builders making complaints about the Building Department. They were posing the question to legal counsel as to public records, if someone requested a record of all contractors. Mr. Carlson's concern was being called by the public looking to hire him as a contractor; now
