

Pursuant to Section 321.261 of the Ohio Revised Code, this Office hereby submits the 2022 Delinquent Tax and Collection (DTAC) report.

The 2022 appropriation for the Treasurer's Office was 380,000.00. The DTAC Land Bank appropriation was \$145,000.00. Expenditures through today, October 17, 2022 are as follows:

Remaining expenditures through 12/31/2022 are expected to be \$55,880.97 for a total of \$353,099.42.

DTAC Treasurer fund (2042-003-100) receipts are estimated at \$263,000.00 which is \$193,000.00 estimated for the County Treasurer's half pursuant to section 321.261 and \$70,000 estimated at Land Bank reimbursement for human resource expenses. Land Bank (2042-003-242-436) receipts are estimated at \$138,000.00. All amounts listed are projections and are subject to change based on budgetary needs and the amount of delinquent taxes collected.
