**CONTRACT BETWEEN ASHTABULA COUNTY COMMISSIONERS AND THE ASHTABULA COUNTY ENGINEER FOR SNOWPLOWING/SNOW REMOVAL SERVICES FOR THE ASHTABULA COUNTY COURTHOUSE COMPLEX, AGRICULTURAL CENTER, EMA COMPLEX, SHERIFF'S GARAGE, 22 EAST JEFFERSON STREET, 30 WEST WALNUT ST. AND THE ASHTABULA COUNTY FAIRGROUNDS FOR THE 2022-2023 SEASON**

The Board of Ashtabula County Commissioners, 25 West Jefferson Street, Jefferson, Ohio, 44047-1092; hereby enters into a contract with the Ashtabula County Engineer, 186 East Satin Street, Jefferson, OH 44047 this 22nd day of November, 2022 for snowplowing and snow removal services to the driveways and parking areas of the Courthouse Complex, County Office Building 12, the Correction and Rehabilitation Center, Agricultural Center, EMA Complex, Sheriff's Garage, 22 East Jefferson Street, 30 West Walnut Street and the County Fairgrounds upon measurable snowfall and removal of accumulated snow piles on a weekly basis for the 2022-2023 season.

The Ashtabula County Engineer hereby agrees to perform said services as outlined herein. The cost of this contract shall be a maximum of \$11,000.00 for the season, payable on or about the 15<sup>th</sup> of each month. The Engineer shall furnish a billing to the Ashtabula County Commissioners at the end of each month beginning November 1, 2022 and continuing through April, 2023. Billing shall be one-sixth of \$2,000.00 (\$333.00) plus \$175.00 for each trip made within that month.
