

RESOLUTION AMENDING RESOLUTION 2021-399, ACCEPTING RESIGNATIONS AND APPOINTING MEMBERS TO THE ASHTABULA COUNTY SENIOR SERVICES LEVY ADVISORY BOARD

WHEREAS, Resolution 2021-399 did not fill the board positions of Michelle Thomas and Rhonda Rodriguez, who did not express an interest in reappointment to the board, and it was recommended to reduce the size of the board from 15 members to 13 members upon the end of their term on December 31, 2021; and

WHEREAS, Virginia Walker and Willietta Bunch-Marbury have not expressed an interest to be reappointed to the board upon the end of their terms December 31, 2022; and

WHEREAS, it is necessary to amend Resolution 2021-399 to not replace board members Virginia Walker and Willietta Bunch-Marbury whose terms end in 2022, and to replace Michelle Thomas and Rhonda Rodriguez with Veronica Hanna and Cristine Rutz so the new appointees term ending dates would end in 2024, as too many board members terms were ending in 2025; and

WHEREAS, The Senior Services Levy Advisory board has recommended that Veronica Hanna and Cristine Rutz be appointed to the Senior Services Levy Advisory Board; and

WHEREAS, The Board of Commissioners concurs with the recommendations and hereby recognizes the ending terms of Virginia Walker and Willietta Bunch-Marbury and the appointments of Veronica Hanna and Cristine Rutz are hereby approved to fill the vacancies of Michelle Thomas and Rhonda Rodriguez for a term effective immediately and ending December 31, 2024, which completes the vacancies to remain a 13-member board; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the amendment to Resolution 2021-399 is approved, as outlined above, for the Ashtabula County Senior Services Levy Advisory Board.
