**Scope of Contract:** To provide transportation services to the general public of Ashtabula County, including limited services to points out of the county for the operation of the Ashtabula County Transportation System (ACTS).

**Provider:** MV Transportation, Inc., 2024 College St., Elk Horn, IA 51531

**Amendment:** increase the total compensation for the period January 1, 2022 through December 31, 2022 from \$1,313,148.00 to \$1,362,211.00, (increase of \$49,063.00) due to the increase in demand for ACTS non-emergency medical transportation.

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the Contract Renewal Option with MV Transportation, Inc. is approved in accordance with the copy now on file in this office.

An amendment to the Agreement between the Ashtabula County Board of Commissioners (Grantee) and MV TRANSPORTATION, INC. (Service Provider) located at 2711 N. Haskell Ave, Suite 1500, LB2, Dallas, Texas dated December 28, 2021 to provide transportation for Ashtabula County individuals determined eligible for these services for the period January 1, 2022 through December 31, 2022.

- I. **Section 10 (Compensation) shall be amended as follows:**  
 Due to increased general passenger and non-emergency medical transportation ridership, the total revenue hours paid to MV Transportation, Inc. for providing these services, will be over the contracted hours of 20,400 for 2022. This amendment increases total compensation from \$1,313,148.00 for the period 01/01/2022 – 12/31/2022 to not exceed the amount of \$1,362,211.00.
