

RESOLUTION AUTHORIZING ASHTABULA COUNTY COMMISSIONER'S DEPARTMENT TO REPLACE, SELL BY PRIVATE SALE AND PURCHASE VEHICLE

WHEREAS, in accordance with 307.41 of the Ohio Revised Code, a resolution setting forth the necessity for the purchase or lease of motor vehicles for use in the aid of departmental duties will be adopted when Commissioners deem it necessary; and

WHEREAS, Janet Discher, Ashtabula County Administrator, has requested permission to replace, trade in and receive authorization for the private sale for the following vehicles:

2014 Dodge Caravan – VIN 2C4RDGBG6ER361812	Mileage: 39,268 (trade in for \$8,000)
2015 Dodge Caravan – VIN 2C4RDGBG6FR599063	Mileage: 37,798 (private sale for \$10,000)

WHEREAS, the cost is under the \$50,000.00 competitive bidding requirement, so in accordance with policy three quotes were obtained from Greg Sweet Ford, Montrose Chrysler and Nassief Ford, with the best local price being at Montrose Chrysler in the amount of \$27,653.00, with a trade in of the existing 2014 Dodge Caravan for \$8,000, thus reducing the cost of the Dodge Durango to \$19,653.00; and

WHEREAS, the 2015 Dodge Caravan is to be sold at private sale to Ashtabula County Juvenile Court for the amount of \$10,000.00; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the Ashtabula County Commissioner's office is authorized to trade in the 2014 Dodge Caravan in the amount of \$8,000.00 to Montrose Chrysler; to purchase the 2021 Dodge Durango from Montrose Chrysler at a total cost of \$19,653.00 and to sell by private sale the 2015 Dodge Caravan to Ashtabula County Juvenile Court for the amount of \$10,000.00.


