All of our staff, Diversion Specialist, Probation Officers etc., were being grossly under paid. We are now in line with the County wage study and we hope that we will have less turn over to other county agencies. Our staff deserve to be paid equally

WHEREAS, after review by the State, some adjustments to the figures were made and as a result Resolution Number 2022-526 needs to be amended to reflect the corrected attachment; now

THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Ashtabula County, Ohio that Resolution 2022-526 adopted on December 13, 2022 authorizing amendment number 1 be made to the Ohio Department of Youth Services for the FY2023 Youth Services Grant in accordance with a copy of said amendment on file in this office is hereby amended to reflect the correct attachment.
