

**RESOLUTION APPOINTING GREG MYERS, EXECUTIVE DIRECTOR OF GROWTH PARTNERSHIP OF ASHTABULA COUNTY, AS ENTERPRISE ZONE MANAGER**

WHEREAS, On April 13, 1989, in accordance with Chapter 5709 of the Ohio Revised Code, the Board of County Commissioners established Enterprise Zones in certain portions of Ashtabula County; and

WHEREAS, Such zones provide the mechanism to utilize tax abatement for qualifying business wishing to locate or expand facilities in Ashtabula County; and

WHEREAS, It is deemed expedient by the Board of Commissioners to appoint a person to manage the applications and associated paperwork and other criteria necessary for the approval of tax abatement by the County and the State of Ohio; and

WHEREAS, a Memorandum of Understanding was approved on October 16, 2016 by and between Ashtabula County and the Ashtabula County 503 Corporation which outlined the Enterprise Zone management functions to be performed by Sarah Bogardus, Director of the 503 Corporation; and

WHEREAS, a letter terminating the Memorandum of Understanding as of December 31, 2022 was received by the Board, which in affect terminates Sarah Bogardus' as Enterprise Zone Manager; and

WHEREAS, It is the desire of this Board to appoint Greg Myers, Executive Director of Growth Partnership of Ashtabula County, as the Enterprise Zone Manager; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that Greg Myers is hereby appointed Enterprise Zone Manager for Ashtabula County, effective immediately and to serve until further notice by the Board.
