

RESOLUTION APPROVING THE VACATION OF A PORTION OF FEE ROAD IN NEW LYME TOWNSHIP BY NEW LYME TOWNSHIP TRUSTEE PETITION

WHEREAS, a petition was filed by the New Lyme Township Board of Trustees to vacate a portion of Fee Road in New Lyme Township, described as follows:

The portion is described, as follows: Fee Road (TH 81 H) 60 foot wide. Beginning at the intersection of centerline of Fee Road (TH 81 H) with the northerly right of way line of Brownville Road (CH 8 F), north to the intersection of the centerline of Fee Road with the southerly right of way line of Dodgeville Road (CH 580 A) about 310 feet.

BE IT FURTHER RESOLVED, That the Clerk of the Board shall forward a certified copy of this resolution to the New Lyme Township Trustees, the Ashtabula County Recorder and the Ashtabula County Engineer.

BE IT FURTHER RESOLVED, once the certified copies of the resolution declaring Fee Road vacated are filed, the New Lyme Township Board of Trustees, by resolution, shall order Fee Road vacated.
