WHEREAS, upon further review, this most likely doesn't meet the definition as a public improvement in accordance with ORC 153.54, and although it is recommended as best practice, the Board does not have to impose a bond under these circumstances; and

WHEREAS, proposals are now re-ordered for Internet Service Providers to Deploy, Operate, and Maintain a Broadband Internet Network in Ashtabula County with a due date of Monday, April 3, 2023 at 2:00 p.m. and will not contain a bid bond requirement; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the proposals be received, rejected and re-issued as outlined above.
