

**RESOLUTION SETTING DATES, TIMES AND PLACE FOR TWO (2) PUBLIC HEARINGS FOR THE ADDITIONAL ASHTABULA COUNTY MOTOR VEHICLE LICENSE TAX**

WHEREAS, pursuant to the Ohio Revised Code Section 4504.24, the Board of Ashtabula County Commissioners are, by the passing of this resolution, setting two (2) public hearings for the enactment of an additional motor vehicle license tax upon the operation of motor vehicles on the public roads and highways in the county, which tax is in addition to the previous taxes levied in Ashtabula County by Section 4503.02, 4504.15 and 4504.16, and any other taxes levied under Chapter 4504 of the Revised Code; and

WHEREAS, additional funds are necessary to adequately finance the planning, constructing, improving, maintaining and repairing of public roads, highways and streets, and the maintaining and repairing of bridges and viaducts; and

WHEREAS, the Board of Commissioners does set the following as dates and times to hold public hearings:

Tuesday, May 16, 2023 at 10:00 a.m.

Tuesday, May 23, 2023 at 10:00 a.m.

WHEREAS, hearings are to be held in the Ashtabula County Commissioners Conference Room, 2<sup>nd</sup> Floor, Old Courthouse, 25 W. Jefferson St., Jefferson, OH 44047; and

WHEREAS, if approved by the Board of Commissioners, the additional five dollar (\$5.00) Motor Vehicle License Tax for Ashtabula County, State of Ohio pursuant to 4504.24 of the Ohio Revised Code will become effective 30 days following adoption of the approving resolution; now

THEREFORE, BE IT RESOLVED, that the Board of Commissioners hereby sets the dates, times and place for the two required public hearings as outlined above.

BE IT FURTHER RESOLVED, that the Board does order the proper legal steps be taken to cause above set public hearings including publication once a week, for two consecutive weeks on April 26, 2023 and May 3, 2023 in Gazette Newspapers.
