WHEREAS, Terry Moisio, had prepared an application and has now received an award from the Ohio Department of Public Safety for use by the Ashtabula County Sheriff's Office, to-wit:

Grant Period: Retroactive to October 1, 2020 to September 30, 2021

Provider: Ohio Department of Public Safety

Purpose: To provide reimbursement for expenditures related to conducting High Visibility Enforcement (HVE) activities in areas impacted by impaired driving and to reduce the possibility of fatal crashes through examples of monitoring for occupant protection, speed, alcohol and drugged driving, aggressive driving, motorcycle crash reduction, failure to yield and other traffic related issues that may contribute to fatal crashes.

Amount: \$65,359.39 in reimbursement for IDEP and STEP direct labor, fringe benefits, transportation costs and STEP education; and

WHEREAS, The Commissioners feel such services would be desirable and is necessary; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio hereby accept the grant in accordance with a copy of said grant on file in this office.
