

RESOLUTION AUTHORIZING THE FILING OF A GRANT APPLICATION TO THE OHIO DEPARTMENT OF PUBLIC SAFETY FOR THE FFY2023 IMPAIRED DRIVING ENFORCEMENT PROGRAM (IDEP)/SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP) GRANT, SHERIFF'S OFFICE

WHEREAS, Terry Moasio, Sheriff's Department, has prepared a grant application to the Ohio Department of Public Safety for use by the Ashtabula County Sheriff's Office; and

WHEREAS, the program for this grant is awarded to law enforcement agencies whose jurisdictions experienced an average of 2.0 or more fatal crashes over the three-year period of 2018, 2019 and 2020 and is designed to create deterrence and change unlawful traffic behaviors where law enforcement efforts are combined with visibility and publicity strategies to educate the public and promote compliance with the law; and

WHEREAS, the federal grant program operates on a reimbursement basis. The administering agency must first incur the cost for approved expenditures and then apply for the reimbursement with appropriate and accurate documentation for each expense; and

WHEREAS, the federal grant period has a 12-month cycle from October 1st, 2023 thru September 30, 2024 in the amount of \$46,836.20; and

WHEREAS, The Commissioners feel submitting this grant application is desirable and necessary; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that an application be made to the Ohio Department of Public Safety for use by the Ashtabula County Sheriff's Office in accordance with the terms outlined in the grant, with a copy of said application on file in this office.
