WHEREAS, in accordance with Ohio Revised Code Section 301.27, on August 2, 2016 by Resolution 2016-204 the Ashtabula County Board of Commissioners established a Credit Card Usage policy; and

WHEREAS, on February 2, 2021 by Resolution No. 2021-12FINA, authorization was granted to county departments for the use of county credit cards with limits established and users approved; and

WHEREAS, it has come to the attention of this Board of Commissioners that the following offices have requested to be included in the County Credit Card program and this board hereby authorizes the following additional county departments for the use of county credit cards, establishes the limits and approves the list of identified users, as follows:
