The purpose of this specification is to describe an acceptable traffic zone marking paint to be used for pavement markings and centerline striping as follows:

Traffic Paint, Type 1, fast dry, water-based 100% acrylic type

7260 Gallons Yellow  
1650 Gallons White

The Ashtabula County Engineer reserves the right to inspect and test any or all of the material being bid, and ask for samples for testing to prove any characteristics which may be in question.

The Ashtabula County Engineer reserves the right to accept a material that does not comply with these Specifications, when such acceptance is in the best interest of the Ashtabula County Engineer and Highway Department.

## REQUIREMENTS AND SPECIFICATIONS

### INTENT

It is the intent of this bid to establish pricing for white and yellow ready-mixed traffic paint suitable for marking various types of pavement. The manufacturer shall formulate the paint in such a manner as to meet the requirements of this specification.

### SPECIFICATIONS FOR TRAFFIC MARKING PAINT:

Specifications shown herein are incorporated into this invitation and made a part thereof are found in the 2019 Ohio Department of Transportation Construction and Materials Specifications Pavement Marking Items 640 and 740 including any and all revisions applicable.

### FINISH PAINT

The paint shall be a suitable binder for glass beads on pavement exposed to traffic. It shall not deteriorate in storage, within nine months after date of receipt, to the extent that it cannot be readily broken up with a paddle to a smooth uniform paint capable of easy application by spray. The paint shall not bleed or discolor when sprayed on bituminous surfaces.

### SAFETY DATA SHEETS

The Bidder is required to submit with their bid, material manufacturers product data sheet, and MSDS sheets for the product(s) being bid. Should the bidder fail to submit this data, their bid will not be considered.

### PRE-QUALIFIED TRAFFIC PAINT
