

RESOLUTION HOLDING SECOND PUBLIC HEARING ON ASHTABULA COUNTY'S PY 2023 COMMUNITY DEVELOPMENT ALLOCATION GRANT PROGRAM APPLICATION TO OHIO DEPARTMENT OF DEVELOPMENT

WHEREAS, on May 25, 2023 a notice was published in the Star Beacon notifying the public of the date and time of this public hearing and listing the projects proposed for funding; and

WHEREAS, Ashtabula County Department of Planning and Development personnel will explain the eligibility requirements, filing requirements, grant period, proposed activities, proposed budget and outcomes of the PY 2023 Community Development Block Grant Programs applications; and

WHEREAS, Jake Brand presented a powerpoint providing an overview of CDBG grant funding opportunities through Ohio Department of Development, Community Services Division, Office of Community Development. The presentation included citizen participation, allocation timeline, application summary/ranking, project funding recommendation, and CDBG PY 2023 Project 1, 2 and 3 Details. Discussion was held regarding the program, staffing, filing dates, amounts, timelines and the process. The allocation amount is \$380,000, 304,000 for the three projects, with the balance for administrative expenses. There were 5 project funding requests received, totaling more than \$500,000. Recommended to fund Village of GOTL street improvement project for \$109,800, ACTS for \$57,000 and Geneva City project ADA improvements at the Senior Center for \$137,200. It was recommended to have the Conneaut Twp. Park be the alternate. The Rock Creek project did not meet the 51% LMI goal, does not according to the 2011/2015 data. They will complete a survey and are hopeful this project could be reconsidered in the future.

WHEREAS, 3 members of the public were present, with no comments being made, the public hearing was adjourned at 10:43 a.m.; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the public hearing held on the proposed grant application to the Ohio Development Services Agency, for PY 2023 Community Development Block Grant Programs funds is hereby adjourned.
