WHEREAS, The County will be submitting the following **Community Development Allocation Application** to the Ohio Department of Development for CDBG funding for the following projects listed with the National Benefit:

- Ashtabula County Transportation System (Public Service) - \$57,000 – LMI Limited Clientele Benefit;
- Geneva Senior Center (ADA Improvement) - \$137,200 – LMI Limited Clientele Benefit
- GOTL Village (Street Improvements) - \$109,800.00 – LMI Clientele
- Administration/FH - \$76,000

Ashtabula County has also identified an alternate project of:

- Conneaut Township Park(Park and Rec Fac) - \$110,000.00 – LMI Clientele
