Ashtabula County has been awarded \$75,000 through the Community Housing Impact and Preservation Lead Assistance Program (CHIP-LAP). The CHIP-LAP eligible activities will be made available to qualified low and moderate-income residents. The program activities are as follows: Lead Abatement in the amount of \$75,000. The lead abatement activity has been reduced to \$60,000 until additional funds are received from ODH. At the time, OCD will process an amendment to add the additional \$15,000 for lead abatement activity.
