WHEREAS, on June 13, 2023 by Resolution No. 2023-329 a grant agreement was approved with the Ohio Department of Rehabilitation and Correction for the Community-Based Corrections Programs 407 subsidy grant; and

Grant Period: July 1, 2023 thru June 30, 2025

Purpose: to provide probation activities for Common Pleas Court

Amount: to increase funding for the CCA 2.0 in the amount of \$24,198.00 for a new total of \$508,158.00 and to increase funding for the PSG award in the amount of \$3,465.00 for a new total award of \$372,769.00

Terms of the Original Contract: All other terms and conditions of the original Contract are not modified by this amendment and shall remain in full force and effect and be considered incorporated herein as part of the First Amendment.


