

RESOLUTION AUTHORIZING ASHTABULA COUNTY ENGINEER'S OFFICE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION (OPWC) PROJECT GRANT AGREEMENT, STATE CAPITAL IMPROVEMENTS PROGRAM, WINDSOR ROAD BRIDGE REHAB/ PLYMOUTH-BECK RESURFACING

WHEREAS, Tim Martin, Ashtabula County Engineer, has presented a project grant with the Ohio Public Works Commission, to-wit:

Provider: Ohio Public Works Commission, 65 E. State St., Ste. 312, Columbus, OH 43215

Description: The project consists of:

Bridge: replace entire substructure, including standard guardrail and bridge rail. Replace/rehab substructure to accommodate 28' wide new substructure. Approach widening and realignment to meet new bridge. Drainage and finish grading.

Resurfacing: Resurface above road way with 1.5" hot mix asphalt 22' wide for 1.85 miles. Refinish compacted aggregate shoulders.

Project Schedule: Construction is scheduled to begin 7/1/2025 with completion by 12/31/2026

Total Costs: Total estimated project cost is not to exceed \$700,000.00, with \$350,000 in grant funds, and the remainder being paid from MVGT funds.

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the project agreement is approved in accordance with the copy now on file in this office.

BE IT FURTHER RESOLVED, That the President of the Board, Casey Kozlowski, is designated as the official signatory of the Board on any future applications and related contracts.
