

RESOLUTION ORDERING PUBLICATION AND BIDS FOR THE COFFEE CREEK WASTEWATER TREATMENT PLANT EXPANSION PROJECT, WPCLF AND ARC FUNDED PROJECT, ACDES, AUSTINBURG TOWNSHIP, OHIO

WHEREAS, Doug Starkey, Ashtabula County Department of Environmental Services Director, has submitted a request to this Board for the publication and solicitation of competitive bids, as follows:

Project Description: The project will involve both an upgrade and capacity expansion of the Coffee Creek Wastewater Treatment Facility in Austinburg, Ohio. The plant expansion will be from 0.15 MGD to 0.225 MGD. Capacity expansion and upgrades will be made for influent pumping, screening, grit removal, flow equalization, extended aeration treatment, tertiary filtration, UV disinfection, aerobic sludge storage/digestion and belt press dewatering. New buildings will include a blower building, a screen building and a sludge press building.

Estimate of cost: **\$5,500,000 with Base & Alternates: \$6,250,000**

Publication: October 5, 2023

Bid Opening: November 14, 2023 at 4:00 p.m.
