

**RESOLUTION TRANSFERRING FUNDS FROM ASHTABULA COUNTY JOB & FAMILY SERVICES TO THE ASHTABULA COUNTY CHILDREN SERVICES BOARD, ACJFS**

WHEREAS, the Ashtabula County Job and Family Services (“ACJFS”) is the recipient of certain Title XX Base Funds and Title XX TANF Transfer Funds, which it receives as part of its annual allocation; and

WHEREAS, on October 1st, 2022, ACJFS received an allocation notice from the State of Ohio, whereby the State set forth the FFY23 Title XX Base Funds allocation and FFY23 Title XX TANF Transfer allocation for ACJFS for the period 10/01/22 through 9/30/23; and

WHEREAS, on October 1st, 2022, the allocation notice indicates that ACJFS has been allocated FFY23 Title XX Base Funds and FFY23 Title XX TANF Transfer Funds in the amount of \$365,176.00 and \$788,220.00, respectively for the period 10/01/22 through 9/30/23; and

WHEREAS, Ashtabula County Children Services Board (“ACCSB”) provides protective services for children and out of foster care services that are eligible expenses for the use of FFY23 Title XX Base Funds and FFY23 Title XX TANF Transfer Funds; and

WHEREAS, in exchange for providing such services, the Executive Director of the ACJFS requests to transfer an amount of \$510,000.00 of FFY23 Title XX Base Funds and FFY23 Title XX TANF Transfer Funds to ACCSB to be used for Non-Allocated Children’s costs; and

WHEREAS, ACJFS finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Ashtabula to authorize the transfer of \$510,000.00 of FFY23 Title XX Base Funds and FFY23 Title XX TANF Transfer Funds to ACCSB, and to authorize the Executive Director of the ACJFS to execute any documents necessary to effectuate said transfer; and

WHEREAS, this Board of Commissioners would agree with the recommendation of ACJFS to transfer said funds; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the Ashtabula County Job and Family Services (“ACJFS”), is hereby authorized to transfer a total amount of \$510,000.00 in FFY23 Title XX Base Funds and FFY23 Title XX TANF Transfer Funds to Ashtabula County Children Services (“ACCSB”) to be used for Non-Allocated Children’s Services costs, and ACJFS is further authorized to execute any documents necessary to effectuate said transfer.
