

**RESOLUTION ACCEPTING RESIGNATIONS, REAPPOINTING AND APPOINTING MEMBERS FOR THE ASHTABULA COUNTY SENIOR SERVICES LEVY ADVISORY BOARD**

WHEREAS, The Board of commissioners created the Ashtabula County Senior Services Levy Advisory Board to assist and advise the Ashtabula County Department of Job and Family Services and this Board in the development and coordination of programs and available services for Ashtabula County's seniors; and

WHEREAS, The initial terms on the Ashtabula County Senior Services Levy Advisory Board are 3 years and were staggered to allow for an orderly progression of re-appointments so that the services of the Board are not disrupted; and

WHEREAS, The following re-appointments have expressed interest and are recommended to be re-appointed: Emory Moore and Sharone Sing, with terms expiring effective December 31, 2023 and renewing on January 1, 2024, with terms ending on December 31, 2026; and

WHEREAS, Pam Zack and Jane Wallace have submitted their resignations effective December 31, 2023 and George Peterson and Ronald Smith have expressed an interest to fulfill these upcoming vacancies; and

WHEREAS, the Senior Services Levy Advisory Board has recommended that George Peterson and Ronald Smith be appointed to fill the vacancies of Pam Zack and Jane Wallace effective January 1, 2024 with terms ending December 31, 2026; and

WHEREAS, The Board of Commissioners concurs with the recommendations and hereby accept the re-appointments of Emory Moore and Sharone Sing, with terms beginning on January 1, 2024 and ending on December 31, 2026 and accepts the resignations of Pam Zack and Jane Wallace and the appointments of George Peterson and Ronald Smith whose terms will begin on January 1, 2024 and end on December 31, 2026; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the resignations, reappointments and appointments, as listed above, are approved for the Ashtabula County Senior Services Levy Advisory Board for terms commencing as outlined above.
