

RESOLUTION RECEIVING THE MALLINCKRODT PAYMENT DEPOSITING INTO THE 2004 OPIOID SETTLEMENT FUND AND DESIGNATING SAID SETTLEMENT TO THE CRIME ENFORCEMENT AGENCY OF ASHTABULA COUNTY (CEAAC)

WHEREAS, Ashtabula County is a Local Government that has adopted and approved the OneOhio Memorandum of Understanding which establishes a mechanism to disburse settlement proceeds from the opioid litigation into Ohio's communities to help abate the opioid crisis, and

WHEREAS, pursuant to the terms of the Memorandum, 30% of the settlement proceeds will be paid directly to local governments, including Ashtabula County, for approved purposes as delineated by the Memorandum, and

WHEREAS, The Crime Enforcement Agency of Ashtabula County (CEAAC) is a multi-jurisdictional crime task force which investigates narcotics trafficking, helping with drug abatement and other multi-jurisdictional crimes throughout Ashtabula County; and

WHEREAS, The Ashtabula County Board of Commissioners is in receipt of the following settlement funds:
