WHEREAS, The term of Commissioner J.P. Ducro IV expires June 14, 2024, with alternate being Commissioner Kathryn Whittington; now

THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Ashtabula County, Ohio, that Commissioner J. P. Ducro IV and Engineer Timothy T. Martin, be re-appointed to the OPWC District 7 Integrating Committee for the term ending June 14, 2027 with alternates Commissioner Casey Kozlowski and Commissioner Kathryn Whittington respectively; and
