

RESOLUTION AUTHORIZING THE BOARD OF ASHTABULA COUNTY COMMISSIONERS TO ENTER INTO AN AGREEMENT WITH HAVE LLC FOR TAX ABATEMENT

WHEREAS, On April 13, 1989, the Board of Ashtabula County Commissioners established Enterprise Zones in certain portions of Ashtabula County pursuant to Chapter 5709 of the Ohio Revised Code; and

WHEREAS, an application has been filed by HAVE LLC for tax abatement who shall invest a total of seven hundred fifty thousand dollars (\$750,000) in an expansion project, including four hundred thousand dollars (\$400,000) to construct approximately a seven thousand square foot (7,000 sf) addition to its facility at 2101 Aetna Road, Ashtabula, Ohio 44004, to construct a new building addition to house additional equipment and staff; and

WHEREAS, Ashtabula Township has developed and agreed to the conditions of tax abatement; and

WHEREAS, The Buckeye Local School District and the Ashtabula County Technical and Career Center have been notified of the tax abatement application by HAVE LLC for ten (10) years at Fifty Percent (50%) abatement for real property; and

WHEREAS, The Board of County Commissioners has investigated the application of HAVE LLC and has found that said company is qualified by financial responsibility and business experience to create and preserve employment opportunities in said Enterprise Zone and improve the economic climate of Ashtabula County; and

WHEREAS, HAVE LLC will present an agreement for tax abatement in the Enterprise Zone for the approval of the Board of Commissioners; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that said Board does hereby authorize itself to enter into an agreement with HAVE LLC for tax abatement in the Ashtabula County Enterprise Zone.
