Scope of Contract: To provide transportation services to the general public of Ashtabula County, for the operation of the Ashtabula County Transportation System (ACTS).

Provider: Sunset Transportation Partners, LLC, 4690 Lake Rd East, Geneva, Ohio

Amendment: This amendment makes changes to clarify language in the original agreement regarding overtime hours. Therefore, the Parties agree to amend Article I. Section 51: Labor Protection: A. Overtime Requirements of the Agreement to read:

- A. Overtime Requirements: No Service Provider will require or permit any driver or mechanic to work more than forty hours in any work week unless such driver or mechanic receives compensation at a rate not less than one and one-half times his or her rate of pay for all hours worked more than forty hours in such work week.


**Amendment to the Service Contract for the Ashtabula County Transportation System


