WHEREAS, after evaluating the submissions, it is the recommendation of Ashtabula County Treasurer Angie Maki-Cliff to the Board of Commissioners to move forward with the acceptance of all proposals, as follows:

- KeyBank to be accepted on an as-needed or per-diem basis to ensure flexibility and coverage for various financial transaction needs
- Paylt to be accepted on an as-needed or per-diem basis to ensure flexibility and coverage for various financial transaction needs
