WHEREAS, Ashtabula County Department of Community Services personnel will explain the eligibility requirements, filing requirements, grant period, proposed activities, proposed budget and outcomes of the FY 2021 Community Development Block Grant Programs applications; and

WHEREAS, Jake Brand presented the following:

The County will be presenting an application for the Community Development Allocation Application to the Ohio Development Services Agency for CDBG funding for the following projects listed with the National Benefit:

- County-wide demolition (Clearance) - \$ 99,000.00 – Eliminate Slum/Blight
- Conneaut Township Park (Street Improvements) - \$128,000 – LMI Area Benefit
- Pierpont Township (ADA) – \$38,000 – Limited Clientele
- Geneva on the Lake (Sewer Facility Improvements) - \$44,000 – LMI Area Benefit
- Administration/Fair Housing - \$71,000

The County will also be submitting an application for a Neighborhood Revitalization Grant for the City of Conneaut for CDBG funds for the following Activities listed with the national Benefit:

- Clearance - \$15,000 – Eliminate Slum/Blight
- Park & Recreation Facilities - \$50,000 – LMI Area Benefit
- Neighborhood Facilities - \$300,000.00 – LMI Area Benefit
- Sidewalk Improvements - \$72,000 – LMI Area Benefit
- Sewer Facility Improvements - \$9,000 – LMI Area Benefit
- Water Facility Improvements - \$54,000 – LMI Area Benefit
- Street Improvements - \$200,000 – LMI Area Benefit
- Administration - \$50,000
