

To Whom It May Concern:

Pursuant to Section 321.261 of the Ohio Revised Code, this Office hereby submits the 2024 Delinquent Tax and Collection (DTAC) report.

The 2024 appropriation for the Treasurer's Office was \$429,805. The DTAC Land Bank appropriation was \$170,000. The DTAC Land Bank appropriation was amended to \$211,647 after a larger than anticipated delinquent tax collection increasing Treasurer DTAC appropriation to \$471,425. A total of \$211,646.45 of the increased appropriation was used.

All DTAC expenditures through today December 1, 2024 are as follows:

The remaining expenditures for 2024 are expected to be \$20,000 for a total of \$438,382.06.

The DTAC beginning balance was \$257,168.78. DTAC balance today, 12/01/2024, \$239,967.32

DTAC Treasurer Fund (2043-003-100) receipts are estimated at \$411,603.23 which is estimated \$199,954.74 for the County Treasurer half pursuant to section 321.261 of the Ohio Revised Code and estimated \$211,646.45 for Land Bank receipts (2042-003-242-436).

All amounts listed are projections and subject to change based on budgetary needs and the amount of delinquent taxes collected.
