

RESOLUTION HOLDING PUBLIC HEARING IN THE MATTER OF THE PROPOSED DISPOSAL OF CERTAIN WATER DISTRIBUTION FACILITIES WITHIN THE COUNTY GENERAL WATER & SEWER DISTRICT (GREEN ROAD), ACDES

WHEREAS, This being the date set by the Board of Ashtabula County Commissioners for the public hearing on the matter of the proposed disposal of certain water distribution facilities located on Green Road in Kingsville Township, the hearing was opened at 1:30 p.m. by Vice-President Ducro and Doug Starkey, Director of ACDES explained the purpose of the hearing; and

WHEREAS, the following is the legal description:

Description: The disposal of approximately 1,900 linear feet of 8” transite waterline extending northward along the western right-of way of Green Road (formerly known as Infirmary Road) from the original terminus at State Route 84 in Kingsville Township and appurtenances.

WHEREAS, The Clerk of the Board will testify that the following is entered into the record:

- **Resolution 2021-SEWA adopted May 11, 2021** declared the necessity and set the public hearing date.
- **Public notice** of this hearing were published in Gazette Newspapers on May 19, 2021 and May 26, 2021.
- **Kingsville Township** was notified on May 29, 2021 by certified mail and the **Board of Developmental Disabilities** was notified of the hearing by certified mail on May 28, 2021.

WHEREAS, there are no written or verbal comments received in this matter; and

WHEREAS, Director Starkey explained that currently Aqua has all the customers on the waterline but do not own the waterline. There have been previous discussions about this topic and we need to move forward.

WHEREAS, there are no members of the public in attendance; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that there being no further testimony offered, the hearing on the proposed disposal of certain water distribution facilities located on Green Road in Kingsville Township, is adjourned; and

BE IT FURTHER RESOLVED, That in accordance with the law, the Board will receive written comments until **June 20, 2021** (5 days) and no further action of the Board will be taken on this matter until after that date.
