WHEREAS, in accordance with Ohio Revised Code Section 301.27, on August 2, 2016 by Resolution 2016-204 the Ashtabula County Board of Commissioners established a Credit Card Usage policy and amended such policy by Resolution Number 2017-246 on August 30, 2017; and

WHEREAS, the policy states no county credit card may be issued to any appointing authority without a resolution from the Board of Commissioners authorizing its issuance, upon the Board's receipt of a written request from the entity and the persons authorized to use such credit card; and

WHEREAS, The following office has requested to be issued county credit cards:


