WHEREAS, Ohio Revised Code §5705.09(F) allows the Board of Commissioners to establish a special fund for each class of revenues derived from a source other than the general property tax, which the law requires to be used for a particular purpose, and

WHEREAS, Resolution Number 2023-526 was adopted on October 24, 2023 by the Ashtabula County Board of Commissioners approving a subgrant agreement with Connect Humanity under Federal ARC-23-C-21004, CFDA No. 23.002; and

WHEREAS, The Ashtabula County Board of Commissioners request that the Ashtabula County Auditor establish a special fund titled Connect Humanity Grant Fund and numbered 2091 in accordance with Ohio Revised Code 5705.09(F) to deposit the grant funds in the amount of \$30,000.00; now

THEREFORE, BE IT RESOLVED that the Ashtabula County Board of Commissioners hereby request and authorize the Ashtabula County Auditor to create a special fund titled Connect Humanity Grant Fund and numbered 2091 to deposit said grant funds in the amount of \$30,000.00 as described in Resolution 2023-526.
