WHEREAS, on October 17, 2024 by Resolution Number 2024-485, a contract was approved for snow plowing/snow removal services for the 2024/2025 season; and

WHEREAS, Tim Martin, Ashtabula County Engineer, has presented a contract for the approval of the Board, to-wit:

**Scope:** for snowplowing and snow removal services to the driveways and parking areas of the Courthouse Complex, County Office Building 12, the Correction and Rehabilitation Center, Agricultural Center, EMA Complex, Sheriff's Garage, 22 East Jefferson Street, 30 West Walnut Street and the County Fairgrounds upon measurable snowfall and removal of accumulated snow piles on a weekly basis for the 2024-2025 season.

**Provider:** Ashtabula County Engineer, 186 East Satin Street, Jefferson, Ohio 44047

**Amendment:** increase amount to not to exceed \$24,000.00 (a \$13,000 increase due to weather)


