

RESOLUTION HOLDING SECOND PUBLIC HEARING ON ASHTABULA COUNTY'S PY 2025 COMMUNITY DEVELOPMENT ALLOCATION GRANT PROGRAM APPLICATION TO OHIO DEPARTMENT OF DEVELOPMENT

WHEREAS, on May 23, 2025 a notice was published on www.ashtabulacounty.us and with five community outreach outlets notifying the public of the date and time of this public hearing and listing the projects proposed for funding; and

WHEREAS, Ashtabula County Department of Planning and Development personnel will explain the eligibility requirements, filing requirements, grant period, proposed activities, proposed budget and outcomes of the PY 2025 Community Development Block Grant Programs applications; and

WHEREAS, Jake Brand presented a PowerPoint providing an overview of CDBG grant funding opportunities through Ohio Department of Development, Community Services Division, Office of Community Development. The presentation included citizen participation, allocation timeline, application summary/ranking, project funding recommendation, and CDBG PY 2025 Project 1, 2 and 3 Details. Discussion was held regarding the program, staffing, filing dates, amounts, timelines and the process, as follows:

The allocation amount is \$408,000. The County will be presenting an application for the Community Development Allocation Application to the Ohio Department of Development for CDBG funding for the following projects listed with the National Benefit:

- Ashtabula County Transportation System (Public Service) - \$57,000 – LMI Limited Clientele Benefit
- Geneva Depot Street Flood and Drainage (Flood and Drainage Imp) - \$153,000 – LMI Clientele Census
- Rock Creek SR45 Sidewalk Improvements (Sidewalk Imp) - \$116,400 – LMI Clientele – Income Survey
- Administration/Fair Housing - \$81,600

Ashtabula County has also identified an alternate project of:

- Windsor Township Community Center Roof Replacement (Rec Fac) - \$101,700 – LMI Clientele Census

WHEREAS, there were three members present at the public hearing; now
