WHEREAS, The Board of Commissioners County Commissioners of Ashtabula County, Ohio has conducted required public hearings to develop a grant application to the Ohio Department of Development, Office of Community Enhancement for the PY 2025 Community Housing Impact and Preservation Grant Program, with said public hearings being published on 5 public forums, seven days prior to the public hearings; and

WHEREAS, The Community Housing Impact and Preservation Grant Program Application will contain the following activities, budget, and outcomes:

- Rehabilitation Assistance - Owner Rehabilitation- \$790,000.00 (HOME & CDBG) – 10 Outcomes;
- Repair Assistance – Owner Home Repair- \$405,000.00 (CDBG & OHTF) – 19 Outcomes;
- Fair Housing- \$10,000.00 (CDBG); and
- General Administration - \$121,000.00 (CDBG & HOME).

WHEREAS, There were no adverse comments to the proposed application; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, that the proposed PY 2025 application for Community Housing Impact and Preservation Grant Program (CHIP) Funds be submitted by the Department of Planning and Development to the Office of Community Enhancement in the Ohio Department of Development, 77 South High Street/24th Floor, Columbus, Ohio 43216-1001 on or before the application deadline of June 25, 2025.
