**Scope:** Amend the agreement with Maximum Elevator & Safety Test Company from June 30, 2021 to September 2, 2021 at a cost of \$2,000 for maintenance of elevators located at:

- Justice Center- Kitchen Freight
- Justice Center- Jail (Passenger & Dumbwaiter)
- Justice Center- Lobby
- Old Courthouse Building
- Soil and Water Building

**Cost:** **Not to Exceed, \$2,000.00**

**Term:** Extend the term of the contract to terminate September 2, 2021;

WHEREAS, the original cost was set at \$90,000 for a 3-year period commencing July 1, 2018 to June 30, 2021;

3. All other terms and conditions of the original agreement remain in full force and effect.


