WHEREAS, pursuant to the terms of the Memorandum, 30% of the settlement proceeds will be paid directly to local governments, including Ashtabula County, for approved purposes as delineated by the Memorandum, and

WHEREAS, The Ashtabula County Board of Commissioners is in receipt of settlement funds from National Opioids Trust Janssen Payment in the amount of \$76,606.27; now

THEREFORE, BE IT RESOLVED that the Ashtabula County Board of Commissioners hereby receives and deposits said funds for the total amount of \$76,606.27 received from the local government share of the Opioid Settlement, into the 2004 Opioid Settlement Fund.
