

**RESOLUTION LIFTING THE STATE OF EMERGENCY DUE TO COVID-19 IN ASHTABULA COUNTY DUE TO OHIO GOVERNOR DEWINE LIFTING THE COVID-19 STATE OF EMERGENCY EFFECTIVE JUNE 18, 2021**

WHEREAS, on January 31, 2020, Health and Human Services Secretary Alex M. Azar II declared a public health emergency for the United States to aid the nation's healthcare community in responding to COVID-19; and

WHEREAS, Ohio Governor DeWine issued Executive Order 2020-01D on March 9, 2020 declaring a state of emergency for the state of Ohio to protect the well-being of the residents of Ohio from the dangerous effects of COVID-19 by authorizing previously alerted state departments and agencies to prepare to respond to this public health emergency as needed; and

WHEREAS, Ohio Governor DeWine lifted the COVID-19 state of emergency, effective June 18, 2021.

NOW, THEREFORE BE IT RESOLVED, by the Ashtabula County Board of Commissioners that due to the State of Ohio COVID-19 state of emergency being lifted, we hereby Rescind the following resolutions;

- 3) Res. No. 2020-147 Delegating Certain Duties to the Ashtabula County Administrator, Pursuant to Ohio Revised Code 305.30
