

**NOTICE OF TIME AND PLACE OF VIEW AND PUBLIC HEARING ON PROPOSED VACATION AND RELOCATION OF PORTIONS GREEN ROAD, KINGSVILLE TOWNSHIP**

Notice is hereby given that there is before the Board of County Commissioners the matter of the proposed vacation and relocation of a portion of Green Road in Kingsville Township, as follows:

**Vacation:** A 616.84' section of old Green Rd. which lies between the centerline of S.R.84 and the centerline of the newly relocated Green Rd.

**Relocation:** An 80' wide relocation, beginning on S.R.84, 265.96' East of the previous intersection of S.R.84 and Green Road, heading northwesterly along a curved centerline, ending at a point 616.84' feet northerly from S.R.84 on existing Green Rd.

The Board of County Commissioners has fixed the 17<sup>th</sup> day of July, 2025 at 9:30 a.m. to view the areas of Green Road in Kingsville Township that are proposed to be vacated and relocated.
