

RESOLUTION AMENDING RESOLUTION 2025-211 REGARDING THE ENGAGEMENT WITH MANSOUR GAVIN, LPA IN ORDER TO ADVISE THE ASHTABULA COUNTY BOARD OF COMMISSIONERS AS LEGAL COUNSEL IN THE CASE OF MARTIN PEASPANEN V. DARLENE BUCK ET AL, CASE NUMBER 2023CV00548

WHEREAS, on April 2, 2025 by Resolution Number 2025-203, the Ashtabula County Board of Commissioners authorized a joint application by the Board and the Ashtabula County Prosecuting Attorney to the Ashtabula County Common Pleas Court in order to advise the Board in matters relating to Case Number 2023CV00548 filed in the Court of Common Pleas; and

WHEREAS, on April 29, 2025 by Resolution 2025-211, the Ashtabula County Commissioners approved the engagement of Mansour Gavin, LPA as separate legal counsel to provide legal services as a result of a conflict which precludes the Ashtabula County Prosecutor from representing, assisting or advising the Commissioners in the matter of Martin Peaspanen v. Darlene Buck et al, Ashtabula County Court of Common Pleas, Case No. 2023CV00548; and

WHEREAS, it is now necessary to amend Resolution No. 2025-211 to set the total compensation for \$20,000, an increase of \$10,000; now

THEREFORE, BE IT RESOLVED, By order of the Board of Commissioners of Ashtabula County, that Resolution 2025-211 adopted by the Board of Commissioners on April 29, 2025 be hereby amended to set the total compensation amount at \$20,000 for the services of Mansour Gavin, LPA who are retained for legal matters described above and as stated in Resolution 2025-211.

BE IT FURTHER RESOLVED, the cost of same shall be borne by the Ashtabula County Board of Commissioners.
