WHEREAS, Tim Martin, Ashtabula County Engineer, has presented a project grant with the Ohio Public Works Commission, to-wit:

**Provider:** Ohio Public Works Commission, 65 E. State St., Ste. 312, Columbus, OH 43215

**Description:** Drainage repairs to ditches, cross pipes, drive culverts, side drains, crack and seat concrete pavement, chip and seal 4.5" overlay, berm restoration, seed and mulch, driveway apron repairs as necessary.

**Project Schedule:** Construction is scheduled to begin 8/1/2026 with completion by 6/3/2028

**Total Costs:** Total estimated project cost is \$1,000,000.00, with \$350,000 in grant funds, 150,000.00 in OPWC loan and the remainder being paid from MVGT funds.

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the project agreement is approved in accordance with the copy now on file in this office.

BE IT FURTHER RESOLVED, That the Vice-President of the Board, Casey Kozlowski, is designated as the official signatory of the Board on any future applications and related contracts.
