

**RESOLUTION AUTHORIZING ADDENDUM TO THE COMMUNITY-BASED CORRECTIONS SUBSIDY GRANT AGREEMENT, COURT OF COMMON PLEAS**

WHEREAS, on June 24, 2025 by Resolution Number 2025-293, the Ashtabula County Board of Commissioners approved the Community Corrections Grants with the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Services, Bureau of Community Sanctions; and

WHEREAS, an addendum has now been presented for the approval of the Board, to-wit:

**Purpose:** To modify the award amounts and add paragraphs 27 and 28 as listed below.

CCA 2.0 Addendum increase: \$50,689.00, New Total Award \$739,136.00

PSG Addendum increase: \$5,359.00, New Total Award \$378,128.00

Total Grant Award for FY 2026/2027 not to exceed: \$1,586,237.00

27. Liability: To the extent allowable by law, each party agrees to be responsible for any liability, suits, losses, judgment, damages, or other demands brought as a result of its own negligent actions or omissions in the performance of this Agreement.

WHEREAS, the Addendum has been reviewed and it is found that such an Addendum would be desirable and is necessary; now

THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Ashtabula County, Ohio do hereby accept and approve the Addendum to Community-Based Corrections Subsidy Grant Agreement in accordance with a copy of said Amendment on file in this office.

BE IT FURTHER RESOLVED, except as modified, the Agreement shall remain in full force and effect in accordance with its terms.


