

RESOLUTION DECLARING THE COUNTY COMMISSIONERS' INTENTION TO PROCEED WITH THE ESTABLISHMENT AND DEDICATION OF A PORTION OF LOCUST DRIVE EXTENSION, SAYBROOK TOWNSHIP

WHEREAS, the Board of Commissioners by prescription, in accordance with ORX 5553.02 has the authority to establish roads (public right-of-way) upon its own volition that will services at least three private residents in the first five hundred feet and one private residents in each two hundred feet thereafter; and

WHEREAS, ORC Section 5553.04 states that when the Board of County Commissioners is of the opinion that it will be for the public convenience or welfare to establish/dedicate a public road, it shall so declare by resolution and set forth the general route and termini for the establishment and dedication:

Establishment/Dedication:

The Country Club Allotment Volume 7 Page 60 in the Ashtabula County Recorder's Office Plat Books. Beginning at the Southeast corner of Lot 5 then northerly to the Northeast corner of Lot 5 then easterly to the Northwest corner of Lot 12 then southerly to the Southwest corner of Lot 11 then westerly to the Southeast corner of Lot 5. The extension of the road is approximately 160 feet long and about 80 feet wide.

WHEREAS, this Board of Commissioners, acting in good faith and in the interest of the general welfare and public convenience is now declaring its intention to proceed with the establishment and dedication of a portion of Locust Drive Extension in Saybrook Township; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that said board hereby declares its intention to proceed with the establishment and dedication of a portion of Locust Drive Extension in Saybrook Township.
