

**RESOLUTION APPROVING CHANGE ORDER NUMBER 2 WITH ABC PIPING CO. AND ASHTABULA COUNTY FOR COFFEE CREEK WASTEWATER TREATMENT PLANT EXPANSION PROJECT, ACDES**

WHEREAS, on February 15, 2024 by Resolution Number 2024-107 a contract was approved with ABC Piping Company and Ashtabula County for the Coffee Creek Wastewater Expansion Project; and

WHEREAS, Doug Starkey, Director of the Department of Environmental Services, has now presented Change Order Number 2 for the Board’s consideration, to-wit:

**Contractor:** ABC Piping Company, Inc., 1277 E. Schaaf Rd. Brooklyn Heights, Ohio 44131

**Project:** The project will involve both an upgrade and capacity expansion of the Coffee Creek Wastewater Treatment Facility in Austinburg, Ohio. The plant expansion will be from 0.15 MGD to 0.225 MGD. Capacity expansion and upgrades will be made for influent pumping, screening, grit removal, flow equalization, extended aeration treatment, tertiary filtration, UV disinfection, aerobic sludge storage/digestion and belt press dewatering. New buildings will include a blower building, a screen building and a sludge press building.

**Change Order No. 2:** Replace existing doors with new FRP doors on the filter building. Engineered shoring system for SHT excavation and relocation of storm sewer conflicting with new aeration tank.

Original Amount:	\$10,293,861.84
Increase this Change Order:	<u>\$ 148,292.47</u>
New Total:	\$10,442,154.31
