

RESOLUTION AMENDING RESOLUTION NUMBER 2018-29FINA ASSIGNING AUTHORITY TO PATRICK ARCARO, DIRECTOR OF THE ASHTABULA COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES, TO ACT AS THE ASHTABULA COUNTY BOARD OF COUNTY COMMISSIONERS' DESIGNEE FOR APPROVING INTER-COUNTY ADJUSTMENTS OF ALLOCATED FUNDS

WHEREAS, on May 8, 2018, Resolution Number 2018-29FINA was adopted by the Board of Commissioners to authorize Director Patrick Arcaro the authority to sign inter-county adjustment agreements, certification release and acceptance of funds and any other documents necessary pursuant to Section 5101:9-6-82 for the acceptance of inter-county transfers of surplus funds from other Ohio counties for the time period to follow the state budget schedule, beginning immediately through December 31, 2025; and

WHEREAS, it has been determined that the resolution needs to be amended to remove the December 31, 2025 termination date and to further reflect the order will continue until December 31, 2026; now

THEREFORE, BE IT RESOLVED, by the Ashtabula County Board of County Commissioners do hereby approve the amendment, as outlined above, to Resolution Number 2018-29FINA with said amendment to be in effect until further order of the Board.

BE IT FURTHER RESOLVED, that all other terms and conditions outlined in Resolution 2018-29FINA shall remain in full force and effect.
